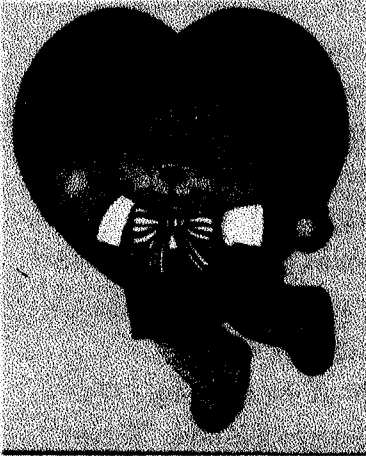

The next meeting of the Unit will be at Jerry's Restaurant in Fallon on Thursday February 18th. Jerry's is on the right hand side of the highway just as you get into Fallon. For my benefit I need to discuss the September activity. Steve and I went down to the Inn in Gardnerville, and discussed using their RV Park so we could attend the Genoa Candy Dance festivities. What we found was that most people who went to the Candy Dance last year immediately made reservations for 1999. Spaces are being held for us until after our February lunch, when we will need to finalize with them. So, I need your input at the lunch in Fallon. For those of you who may be very new to the area, Genoa was the first white settlement in Nevada, originally called Mormon Station. It is unique in many ways. Chief among them is that it does not collect the usual taxes; instead it holds a "Candy Dance" each September and raise all its municipal operating money from those revenues. In 1999 the Candy Dance will be on Saturday and Sunday September 25 and 26. I know, those are not the dates in the rally schedule. The closest available RV parking is at the Carson Valley Inn in Minden. The Inn has some package deals with three days parking included. The questions I need answered are: (1) Would you plan on attending if we scheduled it? (2) Would you want to arrive Thursday and leave Sunday, or arrive Friday and leave Monday, or would you prefer a two night RV parking? (Like Friday and Saturday nights). (3) Would you want to include a Unit buffet in the Inn in a private room one of the evenings? (4) The Inn offers in their packages to provide breakfast two morning for two people per unit. Would you want that? (5) What are you willing to pay for all this? The Inn's package as they structure it comes in at \$115.00 per RV unit. This includes three overnights, two breakfasts, one dinner, and RV parking with full hookups. This can be negotiated downward by eliminating parts of the package.
