Enclosed is an audit listing of your unit. Please verify these records. As directory time draws near, we feel it would be beneficial to have this checked to be sure that those who have paid their dues are listed in the Directory. Members who are WBCCI paid Lifetime members will be shown with an "L" listing.

Some units still have Airstream lifetime members that have not renewed for 2008. They do not have the "L" listing but have a "LIFETIME MEMBERSHIP WBCCI DUES CARD" given to them by the Airstream Co back in 1988. Please check this out. All they need do is pay unit dues and the Airstream Co. will pay the \$55.00 International dues.

Please compare your records with ours and if we do not agree on who is paid for 2008, let us know immediately. Any dues sent in after the above date, until the end of the month, will still be recorded for the directory so you do not need to contact us about these.

YOU NEED NOT RETURN THIS LIST to Headquarters Office - only contact us if an error exists. If there is an error, notify us when dues were sent, check number, date of reporting form, or any other proof that payment was sent to Headquarters. Do not merely report the discrepancy without documentation. Any corrections must be made immediately to meet the November 30th deadline.

Another audit check will be done in the spring and we will go into possible cancellations at that time. If you still have unpaid members, they have until June 30th to pay 2008 dues so don't be hasty to write them off if payment has not been received by "directory time". While they may not be interested during the winter months they may have a change of heart when spring activities start.

Many unit officers are changing at this time. If you are not the current treasurer, please see that the proper person gets this information.

You may wish to review the courtesy parking feature to make sure you have indicated on the dues receipt all your members that wish to have this listing. Enclosed are the names of those we have entered for courtesy parking in the directory. Make sure we have the correct phone number. Let us know if there are any changes.
