Operator at the Red Cross for the recent Esperanza Fire in early November. Unfortunately five fireman lost their lives defending homes in the mountains east of Riverside. He also worked a two day state-wide Hospital Exercise (bird flu epidemic)in November.

Communications Clarification - Recently there have been some heated discussions on Airstreamforums.com Topics related to changing the name of WBCCI, changing the constitution, virtual units, and other organizational issues. For one reason or another many of the allegations and perceptions related to WBCCI, how it functions and why have not been very adeptly clarified by the leadership of WBCCI. This has left many people confused and also left them with misinformation and misunderstandings. Bryan and I have been participating in some of these discussions and as a result other forum members have, on occasion brought in the SNU to try to illustrate their points. As with WBCCI, many of the comments and perceptions are not accurate or are taken out of context. Because the SNU has been directly mentioned, we felt it important to keep the SNU membership informed and also to encourage you to ask questions, express your own opinions, and in general discuss things. First let me say that when Bryan and I express opinions on the forum or anywhere else, they are our own opinions and in no way meant to represent the SNU as a whole. I am sure this is also true for other SNU members who are active on the forums.

One such issue that has come up is that of the ""Whispers" section of the website. It was alleged that this was part of the SNU website. In reality SierraNevadaAirstreams.org is a personal website. A special section of that site has been donated for use by SNU. Whispers is in no way affiliated with SNU or the SNU section of the website. Another issue with Whispers is that lack of awareness that it does fit in with the mission of WBCCI as articulated in Article III of the WBCCI Constitution ""to disseminate information of an advisory and educational nature."" Visiting Whispers, as with any other part of the website is totally voluntary and in no way associated with the SNU or SNU operations. The issue of Whispers came up once before. This prompted a call from the Region 12 President. After discussing the issue and clarifying the situation, the concern was dropped.

Another topic is related to informing and educating SNU members regarding issues that need their input or vote. SNU feels that it's members are capable, informed adults and as such, when provided with basic information on issues, they will make informed decisions and choices on their own. The SNU leadership provides the resources and information needed on issues and is always available to answer questions or provide clarification. The SNU, as mentioned in the last newsletter, has for several years provided multiple methods for members to access information and to provide input. These include rally attendance, online voting and opinion polls, email, SNU newsletter, and phone. This is made possible by a change in 2005 to the SNU bylaws.

There has also been much discussion on the forums regarding the structure and intent of Units and rallies. The general idea seems to be that there should be less structure, formality, and planning and more flexibility. When the SNU went through it's reorganization almost five years ago, these issues were addressed as part of the considerations made by the SNU to help it achieve it's mission. That mission was to get out and go camping in your Airstream with fellow Airstreamers. The SNU followed the principles outlined by the organization founder, Wally Byam in his Creed and Four Freedoms. Part of this concept is seen in the fact that SNU rally events are informal and participation is totally voluntary. Even our business meetings are informal. If you choose to sit by the campfire or watch TV at night, fine. If you want to hike to the top of a mountain and take a few other participants with you, fine. If you want to organize activities and others want to join in, fine.

It was suggested by one forum participant that SNU be a test group and ""we" follow your unit's process or not. Bryan responded by saying the ""SNU does test ideas and has addressed the issues mentioned in this thread - but it does so with the goals and purpose of WBCCI in mind and in accord with its customs, policies, and governing provisions. We show what can be done and how but realize that change is something that cannot be forced on people.""

### 1<sup>st</sup> Airstream Trip

My wife Gail and I, two of your newest members from Southern California, tired of what I lovingly called our old junk motorhome. At my urging we went to the Los Angeles RV show in October 2004 and spent about 8 hours there, 6 at the Airstream displays. We went home the proud owners of a 22' CCD.

We went to Joshua Tree National Park for our first trip. Our 1996 Jeep Cherokee did well even though the Airstream maxed out its towing capacity. We maintained 55 on the freeway even with moderate head winds and the semis didn't push us around. We did well on the long grade on I-10 past Indio until that semi going 30 pulled out to pass his friend going 25. Near Chiriaco Summit we turned north into Joshua Tree. This two-lane road really made the Jeep work; water temperature was pushing 230 in the steeper slow sections.

The steep grades may have slowed the Cherokee down (isn't that what our parent had to do), but boy could it corner! I got surprised by a couple of tight turns and the CCD just followed us through. However, we pulled off at a wide turnout and what did I find when I opened the door; beers & sodas rolling around on the floor, the carton of eggs were there too and the contents of both drawers from the desk at the back. Wow, the trailer will corner much better than its contents.



By mid afternoon we were settled in a campsite immediately next to the main road through Jumbo Rocks Campground. Several people came by to look at the CCD which surprised us at first; we hadn't expect to have so much attention or people taking pictures of the


Airstream.

What a great sunrise on Saturday. After breakfast we visited the park Visitors Center and took the walking tour through the "29 Palms" grove. We picked up some sandwiches and headed off to the Geology Tour in Pleasant Valley. Midway through the tour we detoured down Berdoo Canyon Road (4X4) stopping for lunch on a ridge with a view. After lunch we continued down Berdoo Canyon into the Coachella Valley and filled up the Cherokee.



On the return trip we stopped to chronicle the most difficult section of road (we haven't done a lot of 4 wheeling with this Cherokee) a magnificent view of Pleasant Valley and the 100-year-old water works built by early ranchers.

The best way to close a great day with sunshine, blue skies and shirtsleeve temperatures was the ranger program on desert cougars. Temperature dropped to 43 degrees, not unusual for the desert, it foretold what was coming tomorrow.







Since Jumbo Rocks is isolated from TV, radio and even amateur radio reception from the neighboring cities and towns we left the CCD, headed to 29 Palms to get a weather report and possibly buy a small Honda generator. We made a U-turn before the entrance/exit station because the Ranger was not letting people back in the park. We could see him leaning out the window trying to see why some crazy southern Californians (us) were turning back, but we weren't going to leave our new Airstream there if we couldn't get back in the park. After a couple of hours and with the snow continuing we decided to leave. We had no gloves; mittens nor parkas and we didn't think our coach batteries would last through the day. It took 40 miles of 4 wheel drive to get out of the park that day. What A Great First Trip!


#### To get there
